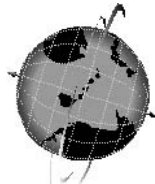

THE CASE OF THE PICKED-ON PEER

Sometimes a prime suspect can make it challenging for your child to learn and make friends. Come on down to this workshop to find out what can be done to **prevent bullying** and to make sure that your child feels safe and happy again.

BREAKING THE CODE

Children with **autism spectrum disorders** often mystify even those who work closely with them. Leave no clue unturned at this session, so that you can break the case to understanding your child's unique needs as he/she gets into the mainstream of life.

DOUBLE JEOPARDY

Anxiety/depression and disruptive behaviors can often make your child's life seem like they are in solitary confinement and drain them of their self-esteem and energy. Learn about a new local website that guides you to mental health therapies that have been proven to help keiki like yours.

THE CASE OF THE UNCONVENTIONAL LEARNER

Students with **learning disabilities** are often misunderstood because of their unconventional learning needs. Make it a point to attend this session to help your exceptional pupil foster future success in school and at home.

CSI: COMPREHENSIVE SENSORY INVESTIGATIONS

Children with **sensory integration** issues have difficulty processing everyday sensations, such as touch, movement, sounds, smells and sights. Get some hands-on information on where and how you can look for ideas that will help your child negotiate through the stimulation of everyday life.

THE CASE OF THE BAFFLING BEHAVIOR



Students often encounter social situations and issues at home and at school that require a group of **social skills** necessary to interact and communicate with others. Learn how to help your child read the social "clues" for the "most wanted" social relationships.

THE CASE OF THE INCLUSIVE CLASSROOM



A good investigator knows that to be an active member of the school community, many students must have an opportunity to experience **inclusive education** in the general curriculum while being uniquely supported. Take a seat in this workshop to learn how you can help your student become a successful agent.

ACADEMICS MADE EASY



The evidence shows that every child learns differently and that **Universal Design for Learning (UDL)** helps to eliminate or reduce physical and academic barriers to learning. Make sure to attend this session so you can solve the mystery of your child's learning environment.

FBI: FINDING BEHAVIORAL INTERVENTIONS



Challenging behaviors can be "dirty" & harry-ing". Learn about the process of **positive behavioral supports** and how it can be used to understand and prevent your child's problem behavior and help maintain law and order in the family.

Children with disabilities struggle with feeling good about themselves and often need more support and reinforcements. Walk the beat to this workshop to witness how you and your child can **think optimistically** as you celebrate the future.

Sometimes you need to take a recess from those heated issues with folks at school or in the community. Find out how parents and professionals can begin **finding agreements** and work through their differences, so they can really focus on their child's/student's needs.
